AGREEMENT

The undersigned, hereinafter called "Debtor" agrees to the following terms and conditions in consideration for money lent, credit extended, goods or services provided by Premier Truck Sales & Rental, Inc., Premier Truck Parts, Inc., or any of their affiliates, successors, or assigns, hereafter called (PTS).

- 1) Debtor understands that monthly statements will include purchase and service invoices through approximately the 30th of each month. Payment of balance on account is due by the 10th of the following month. All invoiced amounts not paid in full within 30 days from the date of invoice will be subject to a monthly service charge of 1.5% per month (18% per annum).
- 2) Any grievance, conflicts, or errors with regard to credit purchase must be reported directly to PTS within (30) days of such purchase. Failure of Debtor to give PTS written notice as above will not otherwise constitute just cause for withholding payment and further credit accommodations may be terminated by PTS.
- 3) Debtor authorizes PTS to obtain such verification and credit reports as PTS deems necessary in investigation of Debtor's financial condition and history. PTS is also authorized to release any information concerning this account to other inquiring potential or existing creditors.
- 4) Debtor hereby grants PTS a purchase money security interest in all goods, and all proceeds of their sale or their dispositions, to secure payment until all debt owed to PTS is paid in full. Further, Debtor agrees to execute a separate security agreement and related financing statements within (10) days after requested by PTS. Debtor hereby appoints PTS as attorney-in-fact for the purpose of executing said documents or making any settlements, disposition, or adjustment in protecting PTS security. All debt owed to PTS arising now or in the future under this Agreement will be subject to any present or future security interest or agreements given to PTS by Debtor.
- 5) The undersigned natural person warrants that they are authorized to sign of behalf of the corporation, partnership or organization under whose name this application is submitted, or will be personally liable for any credit extended on this account.
- 6) Ohio law governs this agreement.
